We place a team of 25 full-time middle school and high school Advisors in 35 schools in our target districts throughout the academic year to personalize the college-bound experience for the students in our program. These advisors forge relationships with Crusaders, encourage them to pursue high academic goals, and run various after school, weekend, and school vacation and summer programs to meet students' academic, personal and social development, college readiness and career exploration needs. College Crusade advisors are a diverse group of young professionals who understand the challenges that young people in disadvantaged

4b (Code:) (Expenses \$ 816,775. including grants of \$ 816,775.) (Revenue \$) Higher Education Scholarship Program: In FY 2017 we provided \$3,135,943 million in cash and donated scholarships to 907 students to support post-secondary success.

4c (Code:) (Expenses \$ 158,355. including grants of \$) (Revenue \$) Crusade Adventure and Academic Program: Middle school is often the time when economically disadvantaged students begin to fall behind their peers in school. The College Crusade provides an intensive program for middle school Crusaders called The Crusade Adventure and Academic Program ("CAAP"), which focuses on leadership development, team building, problem solving, critical thinking and conflict resolution integrated with literacy development. It provides participants with opportunities to take healthy risks while facing progressively more difficult challenges; to learn from their successes and failures; and to build skills that will enable them to overcome the challenges that lie ahead. From focus groups with former participants, it is clear that the program has a long-term impact on their ability to identify the
